  tick (\*') in the appropriate box (

  ), where boxes have been provided. To start a STP, the STP
  Enrolment Form, complete in all respects, must reach atteast 14 working days in advance at
  any of the Official Points of Transactions.
- A single STP Enrolment Form can be used for one Scheme / Plan / Option only. Investor should use separate forms for more than one Scheme / Plan / Option.
- 3. Investors are advised to read the Key Information Memorandum / Statement of Additional Information / Scheme Information Document of the Transferee Scheme(s) carefully before investing.
